## EQUAL CITIZENS

From April 16 to April 19, 2021, Data for Progress conducted a survey of 1138 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, and voting history. The survey was conducted in English. The margin of error is $\pm 3$ percentage points.

NB: subgroups with a n-size less than $50(<50)$ are not shown on these cross-tabs. We choose not to display $\mathrm{N}<50$ subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.
[1] The Senate is currently considering two options to improve our elections. Option one focuses on voting rights protections, campaign finance reform, gerrymandering, and new ethics laws.
Proponents of the first option argue protecting democracy requires comprehensive reform to protect voting rights, end gerrymandering, and stop big money in politics.
Option two focuses solely on protecting voting rights and blocking state-level efforts underway to suppress the vote. Proponents of the second option argue protecting voting rights is the most urgent priority and other reforms, while important, can wait. Between these two options, which would you prefer that the Senate pursue?
